**2020 RATE SCHEDULE
(Adopted by Motion 11/20/18)**

Adopted by the Board of Commissioners pursuant to Resolution No. 3744, Pamela J. Maloney, President of the Board of Commissioners.

RATES AND CHARGES FOR WATER SERVICE

A. **RESIDENTIAL FIXED CHARGE:** A monthly charge based upon meter size:

RESIDENTIAL CONSUMPTION CHARGE: A consumption charge Gallons of water metered bi-monthly, imposed incrementally as indicated below:

Winter – Residential	0-1,496 Gallons	\$0.00/Gallon
Winter – Residential	>1,496 Gallons	\$0.006979/Gallon
Winter – Residential	>18,700 Gallons	\$0.010561/Gallon
Summer – Residential	0-1,496 Gallons	\$0.00/Gallon
Summer - Residential	>1,496 Gallons	\$0.00870/Gallon
Summer – Residential	>18,700 Gallons	\$0.012286/Gallon

B. **NON-RESIDENTIAL:** Non-residential accounts will be assessed the residential monthly fixed charge based upon meter size. In addition, a consumption charge of \$0.006457/Gallon, up to the customer’s average winter bi-monthly usage from the preceding December 1st through May 31st period, will be assessed. Usage in excess of this average (the “Winter Average”) during a two-month billing cycle will be billed at \$0.007072/Gallon.

C. **IRRIGATION:** The residential monthly meter charge, based upon meter size, plus a consumption charge of \$.012286 per gallon.

D. **FIRE SERVICE** – Non Residential: A monthly charge based upon line size:

<u>Line Size (Per Inch)</u>	<u>Bi-Monthly Charge</u>
4"	\$ 45.10
6"	\$ 45.10
8"	\$ 45.10

Plus a consumption charge of \$.014440 per gallon.

E. **FIRE SERVICE** – Residential: A bi-monthly charge of \$6.60, plus a consumption charge of \$.014440 per gallon.

F. **Public School Irrigation** - The residential monthly fixed charge, based upon meter size, plus a consumption charge of \$0.006457/Gallon for consumption up to the customer’s average winter bi-monthly

use for the preceding period, December 1st through May 31st, and \$0.007072/Gallon for consumption in excess of the customer's average winter bi-monthly use.

G. **RATES AND CHARGES FOR SANITARY SEWER SERVICE**

(a) **Residential:**

District Basic Charge \$ 54.30 bi-monthly

Metro (King County
Wastewater Treatment) –
Basic Charge \$ 90.66 bi-monthly

(b) **Non-Residential:**

District Basic Charge \$ 54.30 bi-monthly
District Usage Charge \$0.003971/Gallon over 11,220 Gallons in a billing period

King County
Wastewater Treatment –
Usage Charge \$0.007995/Gallon

Each amount will be billed separately

(c) Exempt Deduct Meter: \$45.10 bi-monthly.

H. **RATES FOR STREET LIGHTING**

(a) A fixed charge of \$7.00 per billing cycle (bi-monthly)

I. **RESIDENTIAL LOW INCOME DISCOUNT RATE – SEWER & WATER**

WATER:

Fixed charge – 50% of the normal monthly charge based on meter size.

Usage – The same as the other residential rates, except that the first 7,480 Gallons are charged at \$.000668

SEWER:

District Basic Charge \$ 44.30 bi-monthly

Metro (King County
Wastewater Treatment) –
Basic Charge \$ 90.66 bi-monthly

J. **OTHER CHARGES IMPOSED BY RESOLUTION**

Each customer shall pay all other charges imposed by Resolution No. 3744 or other District Resolutions.

K. **EFFECTIVE DATE**

This rate schedule shall take effect with utility bills processed on or after February 1, 2020.
